**SUBJECT: B.Com Vocational Courses (RM, A&T)UG 2022-23 EXAMS.**

This appointment is made on the presumption that you are engaged in teaching at University / collegiate / equivalent level and that you do not incur any of the disqualifications enumerated in the enclosed acceptance form. In case of Internal Examiner, it is also a condition that he/she should work as Chief-Superintendent / Deputy Chief-Superintendent / Room-Superintendent if required in connection with University examinations.

The list of other members of your Board among whom you are requested to allocate the setting of Question Papers is enclosed. You are requested to inform directly to the Paper Setters by giving the particulars of the paper/s to be set by him/her, the date of submitting the manuscript question papers etc. Question Paper allotment information should be submitted to this office in Triplicate in the prescribed form of statement duly signed by you. This information has to be reported without fail.

### Note on Question Paper Code (QP Code)

1. Every subject / theory paper shall have a unique five digit numeric Question Paper code (QP Code).
2. Relevant QP Codes are provided with this appointment letter
3. The examiner is required to mandatorily write the QP Code on manuscript as well as on outer cover along with the title of the paper

### Guidelines for Paper Setting

1. The practice of convening the meeting of the BoE to allot paper-setting may be restricted to one day to the Internal Members residing in Bengaluru City University Jurisdiction.
2. At the time of scrutiny of question papers, all the members including Externals should be present and scrutiny to be completed within two days, if necessary, Translation of the question paper to Kannada may be finalized on the third day.
3. The Board should also ensure that all the question papers are set within the prescribed syllabus. If there is any doubt about the syllabus, the Chairman/Chairperson, Board of Studies should be contacted and the doubts to be cleared.
4. Not more than one Paper should be allotted to each examiner. However, the Chairman/Chairperson can allot more than one paper setting to the examiner with prior permission from Registrar (Evaluation)
5. Paper-setting should be given to senior teachers who have put in more than **TEN** years of teaching experience on rotation basis but not to the teachers who have set the paper during last 3 years continuously.
6. The Chairman/Chairperson shall ensure equal distribution of work of valuation among the Examiners.
7. Retired teachers shall not be selected as Paper Setters.
8. The allotment of question paper setting work to be assigned among teachers, who are included in the approved panel of Examiners list.
9. Names of the teachers should be recommended for being appointed as Examiners, only whose names are in approved panel of Examiners.

10. In respect of Languages, the Chairman/Chairperson is required to assign the work, keeping in mind that number of text books in a course and the number of papers to be allotted.
11. Arrangements may be made for setting of **THREE OR MORE DIFFERENT SETS OF MANUSCRIPT QUESTION PAPERS** for each QP Code. All the question papers should be approved at a meeting convened by the Chairman/Chairperson. All the approved set of question papers shall be handed over to the Registrar(Evaluation) on the same day or the next day of the meeting. This stipulation must be adhered strictly.
12. **A paper setter should not be allowed to set more than two question papers of the same QP Code**
13. The blank manuscripts and cloth lined covers may be obtained on a formal indent from the Office of the Registrar (Evaluation), Examination Branch, Bengaluru City University, Bengaluru
14. After preparing the list of question papers to be set based on the information provided by Registrar (Evaluation), the same shall be entrusted to the **eligible paper setters with the following instructions and materials:**
  - a) The order of appointment in writing containing information about the question paper to be set for the QP Code, maximum marks and number of questions to be answered, instruction regarding the use of permissible gadgets in the examination (prohibition with regard to the use of mobile, calculators, mathematical tables etc.) are to be clearly stated on the top of the question paper.
  - b) He/she shall supply syllabus, previous Question papers (if any), blank question paper format, covers etc.
  - c) He/she shall extend all the required assistance and advice to the question paper-setters in determining the standard of the question paper required in each subject of examination
15. The Chairman/Chairperson of the Board shall ensure that the meetings of the Board of Examiners shall be conducted only in the University premises / or any other premises as approved by the University
16. He/she shall also maintain the minutes of the meetings of Board of Examiners and send copies of them to the Registrar (Evaluation).
17. The Chairman/Chairperson shall request the paper-setters who are not the members of the Board of Examiners to attend the meetings of the Board when their papers are taken up for discussion, if need be, under intimation to the Registrar (Evaluation)
18. **Please ensure the conduct of BoE meeting and submission of all manuscript question papers including backlog papers of UG (Degree) First, Third and Fifth Semester on or before 30.12.2022 to the Registrar (Evaluation), Bengaluru City University, Bengaluru – 560 001.**
19. The University reserves its right to use the unused question papers for its future examinations.

### **Guidelines for Theory Paper Valuation**

01. The Scheme of paper setting in QUADRUPPLICATE may be given to the Valuation coordinator / Custodian at the time of valuation under the intimation to this office.
02. Shall handover model answers / scheme of valuation to the Coordinator / Custodian of the valuation center with letter for supplying the same to each one of the Examiners on the day of valuation.
03. Shall verify and confirm the required number of Examiners and ensure that the valuation work is completed within 10-15 days in coordination and cooperation of the Coordinator / Custodian
04. Shall issue letter to examiners for valuation purpose as per the guidelines provided by the Registrar (Evaluation)
05. Ensure arrangements are made for commencement of Valuation work within 5 days from the date of commencement of examination, in consultation with the Co-ordinator concerned and approval for the list prepared from out of the approved panel only after duly certifying to that effect may be obtained from the Registrar (Evaluation) office.
06. Shall ensure equal distribution of work of valuation among the Examiners.
07. Shall coordinate for valuation and review of answer scripts along with Coordinator / Custodian subject to control of Registrar (Evaluation).
08. Shall inform the Coordinator / Custodian QP Code-wise number of packets required for valuation on previous day
09. Shall ensure the proper valuation by examiners / reviewers

### **Guidelines for Practical Examination**

01. Shall ensure that the External Examiners should conduct the practical exams not less than two or more batches in a given day. In case, if they have to conduct other than the specified number, the concerned Chairman/Chairperson, BoE, has to certify to that effect assigning proper reasons. While arranging for the Practical Exams, please ensure that practical exams are conducted only for the candidates whose admissions are approved. Approved candidates list may be collected from the concerned Principal of the colleges. Assignment of Practical work to the teachers should generally be for a minimum of 5 batches. They should be instructed to submit their practical bills within 30 days from date of Practical Exams, to claim their CA/Remuneration/Allowances.
02. Shall arrange with the approval of the Registrar (Evaluation), for the conduct of practical/clinical/projects exams earlier to the commencement of theory examinations in consultation with the Principals/HoD's of Constituent/affiliated/autonomous colleges, and shall assign practical/clinical /paper setting and valuation among the eligible Examiners only, and ensure as far as possible equal distribution of work

Any lapses on the part of Chairman / Chairperson / Paper Setters / Members of BOE shall attract the provisions made under the examination manual of Bengaluru City University. The examination work is mandatory as per the Section 73 & 74 of the KSU Act 2000.
