At the beginning of the first semester a formal matriculation procedure must be completed. For the fall term 2019-20 you are required to report to the University (Via Buffi 13, Lugano, main building, office 234) during the period 5 – 16 September with the following documents:

your Bachelor's degree certificate (original), and the official transcript of exams

The application will be confirmed with the payment of the tuition fee of the first semester according to the enclosed invoice.

The total tuition fee for the two-years' program is CHF 16.000 payable in four instalments of CHF 4.000 to be effected at the beginning of each semester. If matriculation is necessary for any additional semesters after this period, the tuition fee is CHF 500 per semester for the first year and then CHF 1.000 for each subsequent semester.

We suggest that you contact the nearest Swiss representative office to apply for the student visa. Once the application will reach the local foreign office we will be contacted, and we shall provide them with the requested documents after receipt of the tuition fee.

Classes will begin on 16 September 2019. Weekly timetable and other organisational details will be available on USI's website after July-August 2019.

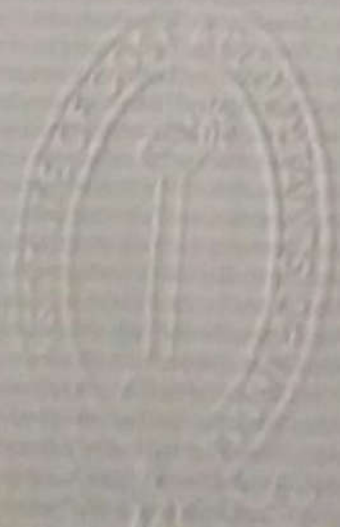

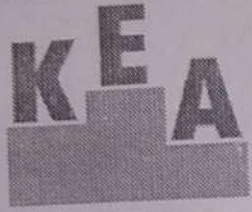

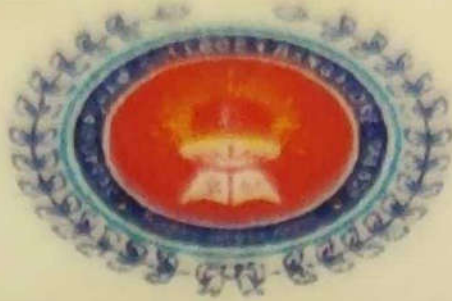
