Report on activities for Academic year 2019-20

1. Orientation programme for the students

On 4th July 2019, inaugural function of new batch 2019-20 was organised. Orientation programme was conducted for students and parents the senior faculty and member of code of conduct monitoring committee Smt. Anuradha.S, oriented the newly admitted students about the college and its culture and also briefed the students and parents about the code of conduct like minimum attendance to be adhered as per university regulations, dress code, discipline, value added course, exam pattern, evaluation guidelines to be followed by their wards.

2. Collected from all the students anti-ragging affidavit duly signed by students and parents by the class teachers.

3. Report on program conducted on professionally ethics, values for students and teachers

- a) On 12th October 2019 Mr. Annamalai, Former IPS Officer who served as SP Udupi, Chikkamagaluru and DCP, Bangalore. Currently, he has embarked on 'We the Leaders Foundation', an NGO, with an aim to contribute to making the society and country great conducted on 12th October 2019 on the Topic 'Values and Ethics in Harnessing the Demographic dividend'. Interacting with the students, Sir spoke about the rich Indian Culture and Heritage using anecdotes from Bhagavad Gita, Quran, Mahabharata and Ramayana and highlighted the importance given to values and culture in the Indian milieu. He urged the students to uphold our culture and tradition which is more than 5000 years old. Speaking on the deterioration and degradation of society, Sir opined that it can be set right by the youth of India by being physically, emotionally and intellectually strong and also by being skilful and mastering the ego.
- b) Prof. M.Siddananda, Retd. Faculty, SJR College, Bangalore on 15th February 2020 on the topic 'The values and ideals of Life in DVG's Mankuthimmana Kagga' Addressing the students, Sir said that the book was published in 1943 and is a collection of 945, four lined verses. Speaking about DVG, he said that the Sahitya Academy Winner of 1967 was a man of great wisdom and also a keen activist and founded the Gokhale Institute of Public Affairs, Bangalore, in memory of his political hero, Gopal Krishna Gokhale. Kagga is considered as Karnataka's and

kannadigas Bhagavad Gita. It is also popularly referred to as 'Gundopanishad'. Mankuthimmana Kagga, Sir opined, deals with everything about life and the beyond and gives the reader and listeners solace, peace and the way out of dead-ends of life. It is a self- help book par excellence that contemplates life and its vicissitudes. It has also been translated into other languages.

- c) An FDP was conducted on the Significance of Code of Ethics on 24th July 2020. The Resource Person for the occasion was Dr. Ganesh Bhatta, Director -Academics and the President of the occasion Prof.K.M.Raghavendran, HOD, Dept. of Physics. Addressing the faculty, the Resource Person, Dr. Ganesh Bhatta spoke about the Code of Ethics and added that it establishes principles for ethical best practices, mindfulness, self-regulation and decision-making and setting the groundwork for self-regulation and self-accountability.
